



# 2024 New Vendor Application

**In order to Participate in the 2024 PA Endless Mountains Fiber Festival you will need to ...**

- Complete and sign this 2024 New Vendor Application (NOTE: This form is not for Food Vendors or Sheep Breed Display participants. Please request appropriate forms).
- e-mail at least 5 clear photos of your product and be sure to include a photo of your booth set up. If you have not previously done any shows we can discuss booth expectations with you. Send all photos to Tina at endlessmtvendors@gmail.com
- Make full payment at the time the application is submitted. Your application and photos will be reviewed and you will be notified of your acceptance. If for any reason your application is rejected you will be notified and your check will be returned to you.
- Donate at least one item to be used for the raffle that will be delivered to the Information Desk preferably at the festival at check in, but before 9:00 am on Saturday, September 7th, 2024.
- Vendors who will have rabbits and/or camelids in their booths must fill in the Animal Exhibitors section of this form and read and complete the 2024 Animal Exhibitor Form (available on our website) and have appropriate health papers. **We must know in advance if you will be bringing any type of animal.\***
- Be set up and remain in place from 9:00 am Saturday September 7th, through 4:00 pm Sunday Sept 8th 2024. Any vendor found dismantling their booth prior to 4:00pm may not be permitted back.
- Vendors are not permitted to sell or sublet their booth(s). All vendors must fill out an application and be approved. Any vendor found in violation risks forfeiture of future participation. *If two or more businesses or persons are sharing a space all businesses or persons and products must be listed on the application.*
- If cancellation occurs by May 31, 2024 vendor will be refunded their booth fee, minus a \$25. processing fee. If notice of cancellation is received **June 1, 2024 or later**, ALL fees are non-refundable.
- Advertising & Sponsor Fees are non-refundable as they will still appear in booklet and on website.

EZ up tents may be used in most areas of the barn, please note if you will be using one so you are assigned a space that permits use.
